## Required Paperwork/Identification on Tow Trucks

The application must be in the name of the Company owner. This is the person that the Permit(s) will be issued to. The Company name is listed on the Tow Truck Cab Card issued by TDLR. The Company name with complete phone number must be on both sides of the front doors in minimum 3" letters. The company's city and state must also be on both front doors in minimum 2" letters. The name and city and state of the wrecker owner found on the Registration Receipt must be on both sides of the wrecker in minimum 2" letters. If all of these documents are in the same name, you do not have to display them more than once. All other required markings must be in minimum 2" letters. Emergency lights (light bar) must be mounted as high and as wide as possible. No additional lighting is allowed including "Wigwag" headlights or alternately flashing "strobe kits".

To be in compliance with any restrictions of the "Move Over Law" you **shall** be equipped with the required lights on your tow truck under Section 547 in the Transportation Code.

Signage must be in contrasting colors, and clearly visible at 50 feet during normal daylight hours (Ordinance II.i.c). No, ghost type signage will be approved.

• PLEASE NOTE: All Tow Truck Company Owner(s) must be present during initial truck inspections.

- 1. Completed application signed by the company owner.
- 2. Business card and wrecker invoice.
- 3. <u>Original CERTIFICATE OF INSURANCE</u> listing all vehicles and driver(s).
- **4.** DBA and/or Incorporated paperwork. A letter of authorization is needed if you are displaying another company's name.
- 5. T.D.L.R. Tow Truck Certificate of Registration & Cab Card
- 6. Tow Truck Registration receipt only.
- 7. Storage Lot letters. (two (2) copies per Lot)
- **8.** Photo identification and license (owner and driver's)
- **9.** MANDATORY You must have an email address for correspondence and updates. Please provide more than one phone number.

The Certificate of Insurance/ACORD must identify all Tow Trucks and Drivers to be permitted and show the below as the **Certificate Holder.** This must be an <u>ORIGINAL</u>, <u>NOT A FAX</u>.
